What if you could give in a meaningful way and truly make a difference in a child's life without any cost?

### Wouldn't you do it?

In the state of Arizona you can! If you're an Arizona taxpayer, the Private School Tuition Tax Credit Program allows you to turn your state taxes into tuition scholarships for eligible children in grades K-12 attending qualified private schools in Arizona.

## How it works

### 1. Decide how much you will donate.

You can contribute the maximum set by the state or your tax liability, whichever is less, and receive a **dollar-for-dollar** tax credit against your Arizona Income Taxes. For the **2023 tax year**, the maximums are **\$2,609** for those filing married jointly and **\$1,307** for a single taxpayer.

### 2. Decide if you would like to recommend a student or a school.

APSTO and state law allows you to recommend a particular student or school benefit from your donation. To recommend a student or school, simply fill out that portion of the donor form as desired.

### 3. Make your donation through APSTO.

### 4. Claim your tax credit.

Take your **dollar-for-dollar** credit on your Arizona state taxes.

## OPTIONAL STUDENT OR SCHOOL RECOMMENDATION

It is regulated by the Arizona Department of Revenue that the final determination on scholarship awards are subject to the discretion of APSTO. Scholarships will be awarded without any regard to the student's race, color, disability or familial status. Scholarships are used for K-12 students attending private schools in Arizona. You cannot recommend your donation go to your own household.

To claim the credit for the previous tax year, make your donation no later than the Arizona tax filing due date, typically **April 15th**. Your donation must be postmarked or entered online by no later than midnight of the tax filing date. There are no extensions.
