

## Change lives without impacting your bottom line.

The Arizona Private School Tax Credit Program allows your company to donate up to 100% of what it owes in state taxes to APSTO and receive a **dollar-for-dollar tax** credit against its tax liability. APSTO turns your tax liability into tuition scholarships, providing much needed assistance for children attending private schools in Arizona.

### Who Can Donate?

- C-Corporations
- S-Corporations or LLC's that file as S-Corporations
- Insurance Companies (that pay premium tax)

### How Much Can We Donate?

C-Corporations may donate up to their state income tax liability for the given tax year, provided it does not exceed the annual statewide cap.

S-Corporations may donate up to up to their state income tax liability for the given tax year, with a minimum donation amount of \$5,000 and then pass the tax credit on to it's shareholders.

**If any corporation donates more than their tax liability, it can be carried forward for up to 5 years.**

### What is the Statewide Cap?

The statewide cap is set annually by the Arizona Department of Revenue (ADOR). The cap opens the first week of July and remains open until the cap is met. Corporations must apply for this program through a certified STO and approved on a first come, first serve basis. In previous years the cap has been met within minutes of the opening.

### Who receives the Scholarships?

Scholarships are generated exclusively to benefit undeserved children (K-12, low income families (A.R.S. 43-1183) OR children with disabilities (physical, learning, or emotional) and children who are currently in AZ foster care (A.R.S 43-1184).

**Corporations can chose to donate to either of these or may recommend their donation benefit a specific school(s).**

# How It Works

## 1. Decide how much you will donate.

Identify your company's corporate income tax liability and determine how much you would like to donate vs pay to the state this fiscal year.

## 2. Decide on your type of tax credit and if you would like to select a specific school(s).

## 3. Submit your Donation Request Form to APSTO.

## 4. APSTO submits a Donation Approval Request to the Arizona Department of Revenue (ADOR).

## 5. Following ADOR's approval, the company has 20 days to make the credit donation or that amount will open back up to other donors (approval based on state caps).

## 6. Once APSTO receives the company's donation, a receipt will be issued to the company to claim the tax credit.

## 7. Claim your tax credit. Take your dollar-for-dollar credit on your Arizona state taxes.

ADOR's donation approval process opens each July 1st. Please return this completed form by the 30th of June for this opening approval cycle. Donation Request Forms may be accepted throughout the year as credit remains available under the ADOR's annual aggregate cap.
