

#### First Step: Decide how much you would like to donate

You may donate up to the maximum set by the state or your actual tax liability, whichever is less. The maximum for tax year 2020 is below.

If you are uncertain what your liability is, you can look at last year's tax form. If you want to be more precise, you can complete your taxes on TurboTax® without making a donation to see what your liability is. Then, rework TurboTax® to reflect your donation.

Keep in mind that your state tax liability is not always what you owe when you file your taxes - it is the total amount you would owe if you didn't pay taxes throughout the year. Provided you stay within the combined maximum provided by the state (\$2, 365 filing jointly and \$1,183 filing single) for your donation, you can carry forward any unused tax credits for up to an additional five years.

#### Final Step: Claim your credit

As you progress through the software program for state taxes, you will come to "School Tax Credits". You will need to check the 3rd box indicated for "Private Schools" in this section:

When you reach the section for "Private School Tuition Contributions", you will need to fill in "APSTO."

- If your tax receipt from APSTO shows the date of your donation was made in 2020, then you will enter your full donation amount in the first box indicated by the blue arrow.
- If your tax receipt from APSTO shows your donation was made between 01/01/21 and 04/15/21, you will enter your full donation amount in the second box indicated by the red arrow.
